The Spirit of Icaros in the New World... An Icarian Odyssey

"Everywhere immigrants have enriched and strengthened the fabric of American life". John F. Kennedy

Driven by regional turmoil, poverty, industrialization and the dawn of the global economy, approximately 350,000 Greek immigrants came to the United States during the first two decades of the twentieth century. Many came because cheap labor was needed during the Industrial Revolution. Others came to augment their families' limited financial resources.

While mainland Greece and other islands had won their independence from Turkey, the Eastern Islands of the Aegean remained under Turkish Occupation. A number of Greeks came from the Turkish Republic to escape the oppression of the Muslim Turks, while others came to escape conscription into the Turkish Army. Whatever the reason, the main goal of each immigrant was to make a better life for himself. All dreamed that someday they would return to a free Greek state.

However, the Greek immigrant paid a steep price for so-called freedom and monetary gain. While desperate to improve their lives, many immigrants endured deplorable living conditions; they became targets of American hostility, were misunderstood by the Anglo population, and felt very lonely.

"When my father, Christos Lardas came to this country in the early 1900's, he was seeking a job. He came across a sign in Gammon's Restaurant in Pittsburgh, Pennsylvania, which said...'Dishwasher wanted...Blacks and Greeks need not apply.'

To overcome these feelings of adversity, the Greeks, as well as other ethnicity's, began organizing themselves into self-contained, ethnically homogeneous groups that evolved into Fraternal Societies.

A social structure then began to develop around these fraternal societies, which offered sanctuary to many and offered public opportunities among compatriots. These *topika somateia* were comprised of members from the same region or village back home. By 1907, there was 100 Greek Fraternal societies.

Numerous Icarians during the early 1900's began to emigrate to the United States and other countries to escape conscription into the Turkish Army. They journeyed to industrialized nations to find jobs and have a better life. Their dream was that someday Icaria would be a free state.

Most Icarian immigrants moved to the cities in the northeastern and north central states. By process of chain immigration, Icarians were able to find work in the steel mill towns of Pittsburgh and Ohio and coalmines of West Virginia. Some traveled to western states such as Colorado, Kansas, and Utah. There, they joined crews laying railroad tracks and worked in copper mines.

1903 According to Icarian-American unwritten history, a group of Icarian immigrants formed a mutual aid group in Pittsburgh, Pennsylvania on January 26, 1903. Their main objective was to provide medical, disability, and funeral benefits for its members and provide a vehicle for raising money for charitable projects for the Islands of Icaria and Fournoi.

1904 The death of John Lefes, the first Icarian immigrant who died in Pittsburgh, was the impetus these men needed to form a fraternal organization. While no relatives stepped forth to bury Lefes, this group of Icarian compatriots collected money to give Lefes a Christian burial. Soon after, this group of men realized that they had a need to form a "*topiko somateio*" that would assist other Icarians with funeral and medical expenses. It was their belief that if they became somewhat organized they additionally would have formal opportunities to meet socially, assist each other finding employment, and support community projects in Icaria. Nicholaos F. Vasilaros and Angelo Tsantes were early leaders of the group. By June 16, 1905, this group of men had filed a petition in the courts of Allegheny County, Pittsburgh, Pennsylvania, for a formal charter that would be known as the Icarian Brotherhood of America. The articles of incorporation state that the Icarian Brotherhood was formed:

"To assist and otherwise extend financial aid to the sick and disable members and pay death benefits from funds collected therein."

This charter documents that the Pan Icarian Brotherhood is the oldest Greek fraternal organization in the Western Hemisphere.

1905 There were 300 paid members.

As an adolescent, Markos Gramatikos (a Fournian) left Agios Kyrikos, Icaria, in 1904 to arrive first on the outskirts of Philadelphia. His first place of employment was in the restaurants working as a dishwasher. Because of his small stature, he had to stand on a crate to reach the sink. He later went on to Monessen, Pennsylvania, to join his maternal uncle, George Katsuleris. In 1907, he entered the employ of Pittsburgh Steel as a painter and worked there until his retirement. In 1911, Markos returned to Ikaria, where he married Kirania Koklanaris. He later re-immigrated to Monessen, Pa. in 1916.

1909 The membership, with a democratic spirit, began to establish rules and laws of a social structure. They corresponded with men, whom they deemed educated, to obtain ideas of governance. They turned to Aristides Phoutrides for direction.

Phoutrides, a Harvard graduate, understood the need for governance and mission. Phoutrides suggested through letters that the first philanthropic objective should be in the direction of education...the building of a high school on the island of Icaria.

"First, you must help the poor, educate the youth, who are unable to educate themselves, by establishing scholarships. Next, establish a library in Icaria that would serve the students and the public. Provide students in Icaria with books, maps, etc."

1910 Pan-Icarian Beneficial Society "Artemis" was formed and chartered in Allegheny County, Pittsburgh, Pennsylvania in October 10, 1910, by Northern Icarians.

"To generous philanthropists and lovers of patriotism lies the reinforcement and completion of this benevolent and patriotic institution which grows as the palm tree in order to foreshadow, reinforce, unite with brotherly love, and cherish all who have recourse to it...above all stands Goddess Artemis (Diana) extending her hand to protect us as she saved Iphegenia in Aulis, supplicating us to prove ourselves worthy of the gift of the laurel crown which she holds to present." "The basis of a democratic state is liberty" Aristotle

1912 After a planned revolt, Icaria became a free state. Icarians from the United States sent money to boost the empty coffers.

August of 1912 Emmanuel B. Contoyiannis delivered a letter and 368 English pounds from Chapter Icaros and the Artemis Society to the Free State of Icaria. This money was earmarked for security and protection on both ides of the island from returning invaders. During this period an Ikarian immigrant that was in America and now in Ikaria sent a telegram to the Ikarian Brotherhood stating that many Ikarians were killed by the Turks. The Brotherhood designated Emmanuel V. Kontoyiannis as their representative and voted to send 306 lyres (to patrol the free state of Ikaria) and 10, 363 franga for arms to the southern part (Fanariou) of the island. The society Artemida of America sent 90 lyres for the northern parts of Ikaria. Once, Emmanuel reached Pireaus (August, 1912) and learned that the bloodshed in Ikaria was false, he sent a telegram to the Brotherhood in the United States stating his findings and halting many men of returning to defend Ikaria. During that period, it has been said that 2000 Ikarian men were in the United States. Fifty men had accompanied Emmanuel to Ikaria and approximately 500 men had returned to serve in the Greek armed forces. Also in Pireaus, Emmanuel deposited the 306 lyres in the Greek National Bank (Ethniki Trapeza) and purchased guns with the remaining monies. The 50 men who traveled with Emmanuel brought weapons from the United States and received some military training. When these fifty men stepped off the boat in Agios Kyrikos, they marched to the municipal building where Malachias welcomed them. Upon reaching Ikaria, Emmanuel's next task was to gather and escort the wives and children (including his own family) of the Ikarian immigrant men to America.

1913 A meeting was held to unify Artemis and Chapter Icaros. The Icarian Brotherhood served many purposes for the new immigrants, assistance in medical treatment, procurement of employment, and providing death benefits to families of members.

Under the advice and guidance of Aristides Phoutrides, the Icarian Brotherhood began to formulate the idea of building a high school.

1919 The Icarian Brotherhood organized the First Drive for the Icarian High School. 500 donors raised \$23,050.30 for the first installment towards the construction of the Icarian high school.

1925 The Icarian High School is completed, at the cost of \$100,000.

1925-1930 V.I. Chebithes, an attorney and dynamic public speaker, encouraged Icarians to join a newly formed organization, Order of Ahepa. A high regard for this newly formed organization gained momentum among Icarians to create an Icarian Society that would unite Icarians on a national level.

1931 V.I. Chebithes formed the Knights and Ladies of Icaria in Akron, Ohio. Additional chapters began emerging in Cleveland, Warren, Youngstown and Steubenville. Others formed in Verona, Pennsylvania, Gary, Indiana, and New York City. Chapter Icaros, however, did not wish to join the Knights and Ladies of Icaria because they did not want to release control of their treasury to a newly formed national organization.

In Youngstown, Ohio, during a national meeting, The Knights and Ladies of Icaria and Chapter Icaros resolved to unite, thus creating the Pan-Icarian Brotherhood of America. The Artemis Society, which was an Icarian organization, evolved into a private social club and did not prove suitable with the newly formed Pan-Icarian Brotherhood. Today, there are 24 chapters in the United States and Canada.

1935 In November 28, 1935, the first convention that the <u>Pan-Icarian Brotherhood</u> was held in Youngstown, Ohio. At that convention, newly forged brotherhood was patterned after the AHEPA, whereby the Icarian and Fournian Chapters throughout the country were combined into a Federation governed by a supreme lodge. A freshly written constitution was approved, which provided guidelines for national governance, local chapters, dues paying members, and annual conventions. At this time it should be noted that women were encouraged to form auxiliaries within each chapter. Their role would be to assist in charitable fundraising.

World War II

1941-1949

- Pan -Icarian Brotherhood raises money for the Greek War Relief Fund. The Italian invasion of Greece in 1940 brought Greece into World War II. A Greek War Relief Association was formed. All the Greek associations in the United States collectively raised nearly 5 million in money and supplies (with AHEPA being the largest contributor) that were sent to Greece.
- Pan- Icarian Brotherhood sells Liberty War Bonds for the war effort and contributes to the Red Cross. In 1944, the United States Treasury honored the Brotherhood for its war bond activities. The Pan-Icarian sold more war bonds than any other Greek organization in America for its size.
- Pan-Icarian Brotherhood sends \$42,000 to Icaria for war reconstruction.
- Many Icarian Americans enlist in the United States Armed Forces.
- Icarian Americans are listed among Killed in Action or Missing in Action.

1956 The next enormous project that the Pan-Icarian Brotherhood initiated was the Clinic, or Hospital in Agios Kyrikos. For many years, medical care for the Icarians in Icaria was an indulgence. Many had to travel to neighboring islands or Athens for emergency medical care during life threatening situations. Some died en route, while others too ill to make this exhausting journey died at home.

John and Sophia Vassilaros, members of the Pandiki Chapter, initiated this humanitarian endeavor. During the 52nd convention, a motion was set forth to examine the concept of constructing a medical facility. Approximately \$11,000 in donations was collected towards this project and the momentum was set forth. The total cost of the hospital was \$71,328. 351 individual donations from Icarians of the USA and Australia totaled \$48,933. The Vassilaros and Lakios family donated the remainder of the balance.

August 23, 1959 The Icarian Hospital, under the auspices of the Hellenic Red Cross, began to receive the sick and injured of Icaria. In 1962, the hospital was enlarged. Since then, the hospital has offered medical care to thousands of Icarians and Fournians.

1962 The concept of aiding others was not a new one. The idea of assisting "*patriotes*" in need was a key tenet of the Icarian Brotherhood in 1903. This thought gave seed to a new concept. A radical idea, creating a Foundation, was first conceived in the minds of John A. Vassilaros, Sophia Vassilaros, and Chris Passodelis while they were traveling to New York in September of 1962. The thought at that time and today was to have a central body within the Pan-Icarian Brotherhood to collect the money and assist with philanthropic projects that the Pan Icarian Brotherhood initiated. During the years of 1963 and 1964, great debates took place within the conventions of the Pan-Icarian Brotherhood because many members did not understand the concept of a Foundation and were concerned about overextending the Brotherhood financially.

1965 In September of 1965, The Pan-Icarian Foundation officially became the philanthropic mechanism of the Pan-Icarian Brotherhood.

The Pan -Icarian Foundation was established with a deed of trust, on September 6, 1965 in Pittsburgh, Pennsylvania. The Foundation charter states that the Pan Icarian Brotherhood will distribute Funds for "religious, charitable, cultural, and educational purposes."

Christopher Passodelis was appointed Director. He was the driving force behind the newly formed Foundation. Mr. Passodelis began establishing the following goals in accordance with the charter.

- Scholarships were awarded to young people to for their education.
- Medical Assistance was granted to overburdened and needy families. The Heart Fund, that assisted the families of children who needed heart surgery was included.

Support towards the Pan Icarian Hospital in Icaria was formalized. In addition, there would be other favorable outcomes that resulted in the formation of the Foundation:

- Contributions made to the Foundation would be tax free in accordance with the law.
- The Scholarship fund that was initiated in 1954 would be expanded.
- The magnitude of philanthropy by the Pan-Icarian Brotherhood would be amplified.
- Contribution systems by the Brotherhood and all its members would become organized and systematic.

In 1967, there was a reported balance in the Foundation after expenditures of \$6,316.73. Today, in 2003, there is over \$2,000,000 in the Foundation.

In addition to his other responsibilities, a key task of the Pan-Icarian Foundation Director is to oversee that projects are expedited in accordance with law. These individuals collectively have diligently championed for Icarian philanthropy and are deserving of accolades and praise.

During the course of many years, the Foundation has undertaken has spent thousands of dollars for the following projects: schools, hospitals, scholarships, Icarian Nursing Home, road building, fire fighting equipment, medical assistance, humanitarian aid to victims of earthquakes, academic research, and support of the Pan- Icarian National Archives.

Ikaria Publication

1960 The need for communication of frequent and consistent information to the members of the Pan-Icarian Brotherhood evolved into a newspaper, a four-page publication by editor Vasilios G. Spanos. Evidence indicates that there were prior issues of this publication from 1930-1960 that were written by Supreme Lodge officers. However, circulation issues were issued inconsistently. In 1979, editor, Nicholas Atchidafty, in Detroit, Michigan, initiated the publication in the magazine format. In 1988, The magazine headquarters relocated to Clearwater, Florida, headed by Stella Pastis Thomas. Since then, the magazine has improved in quality and has grown in volume and circulation. The magazine has been instrumental in the continuing progress towards enhanced communication, thereby propelling the Pan-Icarian Brotherhood and Foundation into the twenty-first century.

The New York Chapter of Fournians became part of the Pan-Icarian Brotherhood as Koursaros #18.

"The Fournian Brotherhood was founded in 1918 in Warren, Ohio. Fournian Chapters were later started in New York and Baltimore. The Warren Chapter still functions as an independent organization".

The first Pan-Icarian Brotherhood Convention is held in Greece.

1990 The latest philanthropic project of the Pan-Icarian Foundation was to provide care for the aged. The concept of building an Icarian Nursing home was initiated and executed. The Icarian Nursing Home is operative and houses a number of senior citizens on the Island of Icaria. The Foundation, through a donation program, has raised more than \$100,000 towards this endeavor

1996 The Pan-Icarian Foundation agreed to support the National Archives and History Project.

Conclusion:

Commemorating the past and assessing the present through the prism of our lives permit us to examine the world from a perspective that remains intensely intimate and rooted in individual experience. Our collective identities will preserve our past and propel us to the future. As keepers of the flame... we pass the torch to the next generation.

Dear Icarian friends and friends of Icarians,

Aristides Foutrides Chapter # 8 has been working diligently to host our 2004 convention in the beautiful city of Chicago. We are confident that you will find it one of the most memorable conventions to date!

The Sheraton is a very popular Chicago hotel and along with that popularity comes the requirement that the first night of your reservation is actually charged to your charge card at the time you make your reservations. This information is on the Sheraton's reservation envelopes sent in the first mailing. Unfortunately, we could not dissuade the hotel from this practice for our convention. This is the hotel's requirement for group bookings as it is also of many Chicago downtown hotels. Of course, if you cancel before the 48-hour deadline, the money will be refunded to your charge card.

We booked our rooms based on the national guidelines and the experience of having hosted previous conventions. As reservations filled, we were able to secure 20% more rooms. The room block is now 120% filled with three months to go. There is a <u>slight</u> possibility that the other two events at the Sheraton may not fill their blocks, in which case we might be able to secure more rooms, but as yet no more rooms are available.

We have contracted with Sheraton's sister property: the Westin Chicago River North at 320 North Dearborn. Both Sheraton and Westin properties belong to the same parent company: The Starwood Group. We will be arranging a shuttle service between the Sheraton and the Westin (approx \$5 by taxi). The group rate is the same at both locations and the added benefit of securing your room at the Westin is that if an opening comes up at our hotel (Sheraton) at the last possible minute, there will be NO last minute cancellation fee to move from the Westin over to the Sheraton. We have no such agreements with any other hotel.

Our hope is to get everyone into the Sheraton, so please keep checking the Sheraton even if you book elsewhere at this time.


